With blink, what you see is what you get and everything is for free except for the following fees and charges:

Yellow Sun Debit Card Fees	
Cash Withdrawal Fees from non-Capital Bank local ATMs	JOD 1 per transaction (please see below note)
Cash Withdrawal Fees from International ATMs	JOD 2 per transaction (please see below note)
International JOD Transaction Fees (Transactions in JOD with Merchants Abroad)	1.5% + currency exchange fees applied by POS acquirer
Currency Exchange Fees (for transactions not in JOD)	3% for transactions in all foreign currencies and 4% for transactions in Euro currency

Cash Withdrawal Fees from Any ATM (local or international)	4% of withdrawn amount with a minimum of JOD 4
International JOD transaction Fees (Transactions in JOD with Merchants Abroad)	1.5% + currency exchange fees applied by POS acquirer
Currency Exchange Fees (for transactions not in JOD)	3% for transactions in all foreign currencies and 4% for transactions in Euro currency
Monthly Interest on used balance	1.50%
Fees for splitting purchases into installments directly on POS machine (for specific merchants)	0.75% Monthly Interest of the Transaction Amount
Late Payment Fees	JOD 10
Credit Card Overline Limit Fees	JOD 10
General Fees	
Certificate Issuance Fees (Liabilities/Interest and Fees Certificate, Clearance Certificate, Balance/Financial Adequacy Certificate, IBAN Certificate)	JOD 5
Issuance of Account Statement Fees	JOD 0.25 per page for period of less than 1 year and JOD 0.5 per page for 1 year or more from request date
Dormancy Fees	JOD 2 Monthly, Up to a Maximum of 6 JOD
Early Salary Withdrawal Fees	JOD 3 If the withdrawal is less than 150 JODs, and 5 JODs if the withdrawal is above 150 JODs.
CliQ Inward Cross Border Transfer Fees	JOD 2 Per Transaction
Delivery Fees for Documents Inside Jordan	JOD 3
Delivery Fees for Documents, Cards Outside of Jordan	JOD 15
Re-issuance & Delivery Fees for Debit or Credit Cards	JOD 5
Debit or Credit Card Objection on Transaction Fees	JOD 5 (Reimbursed if Proven Valid)

Important Note: Maximum limit per cash withdrawal is defined per ATM. This means the amount you wish to withdraw might be withdrawn in two or more transactions. You will be charged for every transaction. For example: if the ATM maximum limit per transaction is JOD 250 and you need to withdraw JOD 500, you will be charged for two transactions. To avoid such charges, you can use any Capital Bank ATM for free or use your cards to pay directly.
