



## World Cup Campaign

### Campaign details/eligibility:

**Use any of blink Cards and services and get the chance to win two game tickets and two flight tickets to attend the World Cup FIFA 2026.**

- Every 10 JOD spent on local transactions using blink credit card and debit card will give you one chance.
- Every 10 JOD spent on international transactions using blink credit card and debit card will give you two chances.
- Issuing a credit card during the campaign period will give you 5 extra chances.
- Opening a term deposit of a minimum of 1000 JOD will give you 5 extra chances.
- Opening a blink account will give you 5 extra chances.

### Terms and Conditions:

1. Customers will be eligible to enter the draw for every 10 JOD spent using any of blink Credit or Debit Card on local and international transactions during the campaign validity.
2. Purchase transactions (POS or eCommerce) are only eligible for this campaign; cash transactions are excluded.
3. Reversed, refunded, disputed, or cancelled transactions will not be counted.
4. The campaign starts on 11.03.2026 and continues until 31.03.2026.
5. The maximum number of chances is 500 per customer.
6. The draw will take place on 05.04.2026.
7. Winners are solely responsible for visa issuance and related procedures.
8. Winners agree to the bank announcing their names on blink social media platforms. Otherwise, the prize will be transferred to another customer eligible for the draw.
